Minutes of 3<sup>rd</sup> meeting of BOG for TEQIP-II held at Dr. S.S.Bhatnagar UICET, Panjab University, Chandigarh on 21<sup>st</sup> December, 2013 at 9.30 a.m.

Prof. A.S. Brar (Vice-Chancellor, GNDU, Amritsar), Dr. G. Munjal (CEO & MD Indswift) and Sh. Manmohan Ahuja could not attend the meeting. Sh. Manmohan Ahuja has expressed his concurrence on all agenda items.

Before taking up the agenda, Prof. U.S.Shivhare, Chairperson, SSBUI CET extended a cordial welcome to the members of the Committee and requested Prof. Meenakshi Goyal, Coordinator (TEQIP-II) to brief about the progress on various activities under TEQIP-II. Accordingly, Prof. Goyal gave a brief presentation on the progress of various activities under TEQIP-II.

As a follow up action on the suggestions given by Prof. Nagabhushan Rao the Mentor (TEQIP-II) during his visit at SSBUI CET, Prof. Goyal informed the members that the work on Procurement Plan has been started. The Quotations for various equipments / instruments have already been invited and opened. A new link has been created on the DR.SSBUI CET website of Panjab University under Heading TEQIP and information related to TEQIP-II is being updated on weekly basis. The report or document on NBA Accreditation Performance is under process. The Student Survey has also been done.

Vice-Chancellor initiated the discussion. In the end he suggested that keeping in mind the long association of Prof. R.K. Wanchoo, Prof. V.K. Rattan with the Institute, they will be invited in the meeting of the BOG as special invitee so that their expertise be used for the betterment of the Institute.

Prof. S.K. Sharma suggested that:

1. For Skill Enhancement of Undergraduate Students, the workshop on Design of Equipments of 1-2 days duration conducted. One week Entrepreneur Development Programme should be held wherein lectures should be organized on Preparing Balance Sheet, Arranging Seed money for business ventures, writing project report and experience sharing by first generation entrepreneurs. In addition NABL training and Patent Workshop may be conducted under TEQIP-II.
2. Purchase of the equipment should be made in such a manner that the institute should be able to promote consultancy for industry. It may also be ensured that the certificate of calibration and accuracy is obtained at time of purchasing and AMC should be done.
3. The syllabus for practical subjects be thoroughly revised so as to make them more relevant keeping in view the latest developments.
4. Efforts must be undertaken to make the equipments in the Unit Operation Lab. Operational
5. The students may be encouraged to visit the industries on the weekends.
6. For the maintenance of the equipments, 2-3 people from technical staff from SSBUI CET be deputed in the CIL department and may be trained on various instruments.
7. List of old equipments lying in the institute may be prepared so that those can be upgraded/replaced. For the new equipments which are being purchased, calibration curve should be obtained from the vendors.
8. Softwares for the students to be purchased.
9. Soft copy of Special lectures may be purchased under TEQIP-II and placed in library for the access to students.
10. Setting up of Process Control Lab.

**The following decisions were taken by the BOG:**

**Item No.1**

- i. To approve the guidelines for the award of assistantship to the Ph.D students of Dr. SSBUI CET.
- ii. To approve the award of assistantship to the Ph.D students @ Rs. 18000 + HRA under the Budget Head "Providing Teaching & Research Assistantship" of Dr. SSBUI CET.

**Item No.2**

To approve the guidelines and award of assistantship to the post graduate students, M.E. (Chemical) & M.Tech (Polymers) @ Rs. 8000 per month under the Budget head “Providing Teaching & Research Assistantship” to the Non- GATE qualified students & to approve that the students may be awarded assistantship from 11<sup>th</sup> October 2013; the date of approval from Honorable Vice Chancellor.(Annexure – 2)

RESOLVED: That the item be approved as proposed. The students will submit the report on quarterly basis and their Saturday will be a working day.

**Item No.3**

To approve the award of assistantship to M.Sc (Industrial Chemistry) students @ Rs. 5000 per month under the Budget head “Providing Teaching & Research Assistantship” & to approve that the students may be awarded assistantship from 1<sup>st</sup> January 2014.

RESOLVED: That the award of assistantship to M.Sc (Industrial Chemistry) students @ Rs. 6000 per month w.e.f. 1<sup>st</sup> January 2014 under the Budget head “Providing Teaching & Research Assistantship” with Saturday as working day. The students will submit the report on quarterly basis.

**Item No.4**

The autonomy to the Dr. SSBUI CET, Panjab University, Chandigarh w.r.t. functioning of TEQIP-II was granted by the syndicate in its meeting held on 27<sup>th</sup> July 2013 reference paragraph no . 41. This is for kind information for the Board of Governors. (Annexure – 3)

**Item No.5**

RESOLVED: That the TA/DA rules for the undergraduate/ Post graduate/ Ph.D. Scholars of Dr. SSBUI CET students to present papers in the National Conferences / Seminars / Workshops etc. be approved with AC II/III tier and Rs.10,000/- as the upper limit for expenditure. (Annexure – 4)

**Item No.6**

In view of the autonomy given to Dr. SSBUI CET, Panjab University, Chandigarh with respect to the functioning of TEQIP-II by the syndicate, the bills are to be pre audited under TEQIP-II before the payment is released. An auditor from Institute of Public Auditors local Chapter situated in AG Office Punjab, Chandigarh has been recruited and duly approved by the Vice Chancellor, Panjab University, Chandigarh (already recruited by UIET) at a remuneration of Rs. 12500/- per month and service taxes for utilization of services of Auditor on part time basis.

The auditor recruited may be approved.

Salary will be charged from the Budget Head “Incremental Operating Cost”

Three research proposals have been submitted by the Under Graduate Students and are placed for approval of Board of Governors. All faculty members should be encouraged to attend International Conferences / Seminars / Workshops etc. All the faculty members will give a seminar after they attend an International Conference/Workshop/Seminar etc. The committee further recommended that the faculty should be encouraged to visit reputed International Laboratories after attending International Conference to promote collaborative research.

**Item No.10**

To approve Local Conveyance under TEQIP-II.

- i. Local Conveyance for Coordinators of the workshop/Seminars/Conference/FDP etc as per the actual may be reimbursed as per Panjab University rules for official work.
- ii. Local Conveyance for TEQIP-II cell staff and Non-teaching Staff of Dr. SSBUI CET as per the actual may be reimbursed as per Panjab University rules for official work.

RESOLVED: That the item be approved as proposed.

**Item No.11**

To approve an amount of Rs. 100 (per day) for Class C employees and @ Rs. 250 (per day) for Class A and Class B employees for FDP/ SDP/ Seminar etc running more than a day.

To approve an amount of Rs. 150 for Class C employees and Rs. 350 for Class A & Class B employees for one day workshops/ seminar/ SDP etc.

The committee was of the opinion that instead of recruiting more persons under TEQIP-II the institute should involve the non teaching staff of Dr. SSBUI CET for TEQIP work and they may be paid an honorarium of Rs. 2000 per month from the Head "Incremental Operating Cost" after the approval from Coordinator (TEQIP-II)/ Chairperson, Dr. SSBUI CET.
