OBJECTIVES

The scope of corporate governance should extend to corporate responsibility. Ministry of Corporate Affairs has laid down the National Voluntary Guidelines (NVGs) on Social, Environmental and Economic Responsibilities of Business in order to work within the framework of national aspirations and policies. With a view to provide a framework for companies (private and public) to implement need-based CSR activities, the Government of India has included CSR-related provisions in the Companies Bill, 2012.

These recent and radical changes indicate a paradigm shift in definitions of purpose and responsibilities of a modern institution; be it private or public. Hence, it is of utmost importance for the next generation scholars to understand these concepts in theory and practice. Our aim through this FDP is to build a conceptual understanding of Corporate Governance, Business Ethics and Corporate Social Responsibility for the participants. In order to acquaint the participants of the pragmatic aspects of the topics we look forward to experience sharing sessions with academicians, researchers and distinguished professionals from the private and the public sector.
